The Austin County Fair will be holding a contest for the cutest babies & toddlers in the pumpkin patch. The pumpkin patch will be set up at the Fairgrounds from September 29th through October 8th for pictures. So bring your baby or toddler to the fairgrounds and start snapping those cameras!

PUMPKIN PATCH PHOTO CONTEST RULES

1. All babies and toddlers must be a resident of Austin County. There will be four age categories:

0 - 6 Months (must not turn 6 months before October 1, 2007)

6 - 12 Months (must not turn 1 before October 1, 2007)

1 - 2 Years Old (must not turn 2 before October 1, 2007)

2 - 3 Years Old (must not turn 4 before October 1, 2007)

2. Pictures must be taken in the Austin County Fair Pumpkin Patch between 10:00 a.m. and 7:00 p.m. beginning Saturday, September 29th and ending Sunday, October 7th. The Pumpkin Patch will be located in the Commercial Building. (No Professional Photographers)

3. Photo & entry form must be turned into the fair office by 5:00 p.m. on Monday, October 8th with a \$10 entry fee per photo. Photograph must be a 4x6 or a 5x7 print.

4. Photos will be judged on Tuesday, October 9th. Contestants may win only once per category.

5. Photos will be displayed in the Commercial Building until Sunday, October 14th. Photos and awards may be picked up at the Fair Office beginning Monday, October 15th. Awards not picked up by November 1, 2007 will be

forfeited.

6. The winners in each age category will receive the following:

1st Place - \$100 Savings Bond & a Ribbon

2nd Place - \$50 Savings Bond & a Ribbon

3rd Place - \$50 Savings Bond & a Ribbon

All others will receive a participation ribbon
